The development team generates detailed financials for proposed projects, which are updated throughout the pre-development process.

General Contractor: Mosites was founded in 1959 and has over 60 years of experience in the general construction industry in the Pittsburgh region. As on of the leading construction firms in the region, Mosites has experience in commercial, institutional, recreational, renovation and heavy highway construction projects. Mosites has worked on a number of low income affordable housing projects including multiple 9% LIHTC new construction projects and renovations of Wood Street Commons, a SRO

building similar to this project. At this point, Bethlehem Haven is going through negotiation with Mosites and has not signed a contract yet.
