



ANNETTE M. FETCHKO, RN, MHA Executive Director – Bethlehem Haven – part of the Pittsburgh Mercy System of Care

Annette has dedicated much of her career to improving access and quality of care for persons in our communities who are most vulnerable, as evidenced by her many years of service to those in need in the most at risk communities throughout western Pennsylvania. Annette is the Executive Director – Bethlehem Haven – whose mission is to serve women experiencing homelessness, and the first of its kind in the region medical respite program for homeless and unstably housed individuals in need of recuperative care services that do not meet the criteria for skilled services.

Annette previously served as director of strategy for Allegheny Health Network's (AHN) Center for Inclusion Health where she lead strategic planning for initiatives that address access to services for marginalized and at-risk populations and sustainable models to close gaps in the social determinants of health. Annette implemented the first-ever Healthy Food Center in Western Pennsylvania to address food insecurity and a doula program for the immigrant population. She collaborated in the development of Bethlehem Haven's Medical Respite Program, a community-based health and human service collaborative to address housing insecurity for people who are experiencing homelessness or unstable or unsafe housing. Annette also collaborated on the development of reimbursement models for programs and services related to the social determinants of health.

Prior to her work at AHN, Annette was the administrator of the Catholic Charities Free Health Care Center. Annette has held multiple other leadership, professional, and management positions at Alle-Kiski Medical Center (now AHN Allegheny Valley Hospital), Pennsylvania Select, Inc. (now Quorum Health Resources), UPMC Physician Hospital Organization, Pyramid Health, and VHA Pennsylvania.

Annette is a licensed registered nurse in the Commonwealth of Pennsylvania. She earned an Associate of Nursing degree at St. Margaret Hospital School of Nursing and has direct care and nursing leadership experience. Additionally, Annette earned a Bachelor of Science degree in psychology at The Pennsylvania State University, and her Master of Health Administration degree at the University of Pittsburgh Graduate School of Public Health.

 youth who have aged out of foster care, we achieved 100% voter registration for the 2020 election.
